Southend Airport:

Gary Pearce and myself have worked on the asbestos problems at Southend Airport. The level of unsafe asbestos was most disturbing and led to a site visit from a HM Inspector of Health & Safety from the HSE. The report identified contraventions of health and safety law and the London Southend Airport Company were given actions to complete and given an action date by 1st September 2017. A full report was provided by HSE giving their reasons and required action as below:

MATERIAL BREACHES - NOTIFICATION OF CONTRAVENTION

1) Control of Asbestos Regulations 2012, Regulation 10 and Management of Health and Safety at Work Regulations 1999, Regulation 10

Asbestos awareness training and information

Reason(s) for opinion(s):

Whilst investigating a concern raised with the HSE regarding fire officers being potentially exposed to asbestos fibres, it became apparent that some employees who are required to work in locations that contain ACMs were not provided with sufficient information, instruction or training on the risks of asbestos. This may have contributed to the confusion and unease experienced by some fire officers working in the appliance bays who incorrectly presumed they were at risk of exposure. The above regulations require that employees are provided with comprehensible and relevant information on the risks to their health and safety, including the risk of exposure to asbestos. Anyone liable to disturb asbestos during their work, or who supervises such employees, must receive the correct level of information, instruction and training to enable them to carry out their work safely and without risk to themselves or others.

You are required to take the following actions:

You should provide asbestos awareness training for all employees that work in, or use, buildings and facilities that contain ACMs. Asbestos awareness training should cover the following topics:

- *The properties of asbestos and its effects on health, including the increased risk of lung cancer for asbestos workers who smoke;*
- *The types, uses and likely occurrence of asbestos and ACMs in buildings and plant;*
- *The general procedures to be followed to deal with an emergency, e.g. an uncontrolled release of asbestos dust into the workplace;*
- *How to avoid the risks from asbestos, e.g. for building work, no employee should carry out work which disturbs the fabric of a building unless the employer has confirmed that ACMs are not present.*

Additional training, at an appropriate level, should also be provided to supervisors, managers and directors to assist them in complying with their legal duties under the regulations and to enable them to effectively carry out their role during any work involving ACMs.
